



On Both Ends of Capitol, Both Parties Warn Big Pharma on Drug Prices

New York Times, 1.30.19 Members of Congress from both parties served notice on pharmaceutical companies on Tuesday that the days of unchecked drug-price increases were over and that they would be held politically accountable for exorbitant prices. The new reality became apparent at simultaneous but separate hearings of House and Senate committees where lawmakers said that the relentless increases were unsustainable and unacceptable.

BCBS Of North Carolina Awards \$2M To Projects Tackling Opioid Epidemic

Fierce Healthcare, 1.29.19 Blue Cross and Blue Shield of North Carolina has awarded \$2 million to five groups working to address the opioid epidemic in the state. Awardees include Duke University Health System, which launched Symmetry, a mobile health tool that aims to standardize screening and prescribing habits for opioids. Another group, Together for Resilient Youth, aims to prevent addiction in young people. The five awards are a piece of BCBS of North Carolina's \$10 million investment in addressing the addiction crisis, announced last year.

Analytics Gives HCSC The Pulse Of Provider Care
